India and China Discuss Next Steps to Strengthen Ties

At the G20 Summit in Rio de Janeiro, External Affairs Minister S. Jaishankar met his Chinese counterpart, Wang Yi, to discuss steps for improving India-China relations. The focus was on resuming key exchanges, including:

- •Kailash Mansarovar Yatra: Talks about reopening the pilgrimage route.
- Direct Flights: Restarting flights between the two countries, suspended since COVID-19.
- Data Sharing: Renewing the exchange of border river data.
- Visa Services: Simplifying visa policies for mutual benefit.

discussions follow These disengagement agreement along the Line of Actual Control (LAC), easing tensions since the 2020 standoff. Both nations agreed to further talks between their National Security Advisors and Foreign Secretaries.

On the economic front, China expressed interest in resetting trade ties with India, citing opportunities in India's growing middle-class market. Beijing is also preparing fiscal measures to stimulate its economy in 2024.

- •Established in 1923, it has 196 member countries.
- ·Coordinates global police efforts through its headquarters in Lyon, France.
- •India's Central Bureau of Investigation (CBI) acts as the national contact point for Interpol.
